Stabilizing the U.S.-China Rivalry

This report assesses possible means of stabilizing the U.S.-China rivalry. It reflects the findings of a study in which we first examined the challenge of stabilizing strategic rivalries and the principles

for doing so. We then assessed Chinese strategic intent, evaluating several recent analyses of Chinese-language documents, to determine the scope for stabilization. Finally, the study involved pairs of U.S. and Chinese scholars outlining the potential for stabilization in three issue areas: Taiwan, the South China Sea, and competition in science and technology. The report concludes with specific recommendations both for general stabilization of the rivalry as well as initiatives in each of those three areas.
